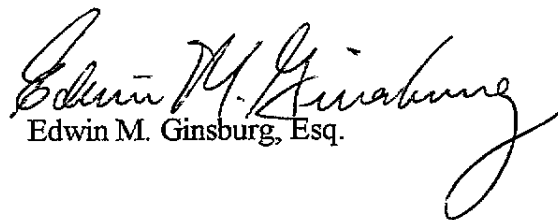

FIRST: The name of the corporation is: PETRUS OF FLORIDA, INC., a Florida corporation.

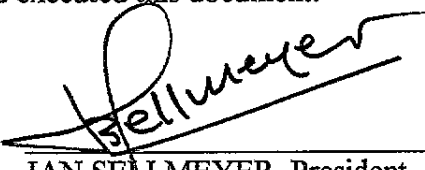
SECOND: The dissolution was authorized and approved by all of the directors and shareholders of the Corporation on August 13, 2001, to be effective immediately.
