To Whom it May Concern:

Our firm represents Rosenthal Collins Securities, L.L.C. ("RCS"), and this letter is in response to a notice of administrative revocation by your office against the above broker-dealer. In July, 1999, RCS forwarded a notice of delinquency in the filing of the Florida Annual Report for 1999. In reviewing the file in this matter, we discovered that the annual report for 1999 was indeed signed and filed on March 8, 1999, and forwarded with payment to your offices.

On July 12, 1999, I personally telephoned your office and spoke with a woman named Jane (who would not give her last name) in the Annual Reports Department to inquire about the July 3,-1999, notice from your office. She advised me that due to a significant "back-up" in the department, many annual reports were yet to be processed. She advised that I call back in two weeks. Approximately two weeks later, I again called the Annual Reports Department, only to be told "not to worry about it as it will eventually be processed."

Having no other direction upon which to act, having already submitted the form and appropriate fee, and having heard no response since the July, 1999, conversations with your office, RCS could only presume that the Annual Report was recorded. As such, your office's determination that RCS failed to respond to the July 3, 1999, notice is incorrect and the administrative revocation is improper and should be reversed.
