Pursuant to the provisions of Section 607.1109 of the Florida Business Corporation Act (the "Act"), the undersigned eatities do hereby make and execute these Articles of Merger for the purpose of merging Gold Coast Travel Agency Corporation, Inc. into Cruises Only, LLC (the "Merger"):

- A. The Agreement and Plan of Merger ("Agreement of Merger") is as follows:
