Dear Mr. Logan:

Enclosed are a number of items that I would like to review with you. I spoke with Lee Rivers in your office on May 14th, and he asked that I follow-up with a letter to you with all of the enclosed materials.

Atlantic Partners Group II, L.P. – I received the enclosed letter dated April 21st, 1999 and Certificate of Revocation for Atlantic Partners Group II, L.P.. The reason stated for revocation is failure to submit its 1999 limited partnership annual report. My records indicate that the report was filed on 3/12/99 with Check # 2972 for \$141.25 enclosed. The report and check were returned to me for an incomplete FEI # which was still marked "Applied For". The FEI# was completed and the report was refiled on 4/7/99, well within the 60 days specified on the letter. To date, the report has not been returned to me. Lee Rivers mentioned that the letter was supposed to have said 30 days but noted that a number of letters evidently went out with the incorrect time period. Lee suggested that you would take care of this matter. Therefore, I assume that the entity can be reinstated in good standing without completion of the Application for Reinstatement or related fees/penalties.

Atlantic Partners Group, L.P. – I received a letter dated March 23, 1999 acknowledging receipt of the annual report for Atlantic Partners Group, L.P. but returning it since its general partner, CIMC Atlantic LLC, was shown to have been revoked. Again the letter attached said I had 60 days to respond; however, subsequently I received a letter dated April 21st, 1999 and Certificate of Revocation for Atlantic Partners Group, L.P. for failure to file its annual report. Again, Lee pointed out the error on the date and suggested that you could take care of this matter.

When researching this matter, I found that I had never received any correspondence regarding the original annual report, the subsequent notice for failure to file, or the letter or certificate of revocation for CIMC Atlantic LLC. Lee did note that your records indicate having sent letters on both 10/21/98 and in 6/98; however, I never received them while I have received every other communication from your office. It appears that the information was sent to the wrong address; I have enclosed a copy of a Corporate Detail Record Screen (dated 3/23/99) which I received either

from your office or from Randy Fairbanks, our Registered Agent, which shows the mailing address as 26211 Marsh Landing Parkway rather than the correct address, 26221 Marsh Landing Parkway. You will note that all correspondence for related entities (which I did receive) was sent to 26221 Marsh Landing Parkway.

CIMC Atlantic LLC – As noted above, I have never received any of the reports, letters or notices due to the incorrect mailing address in your system. However, I would like to have this entity reinstated. Therefore, I have enclosed a completed application of reinstatement. Due to the clerical error I believe that the reinstatement fee of \$500 and supplemental fee of \$88.75 should be waived. I have enclosed a check in the amount of \$108.75, representing the Annual Report Fee and Certificate of Status Desired fee.
