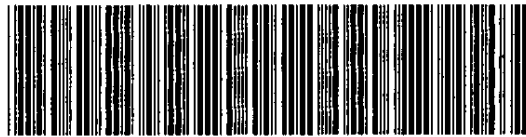

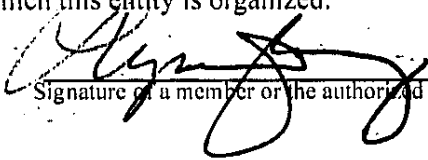

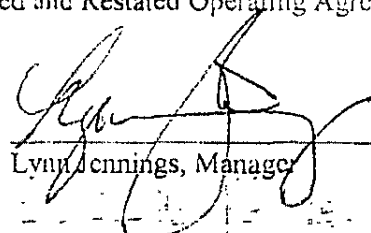
**FIRST:** The name of the company is Alliance Underwriters, LLC (the "Company");

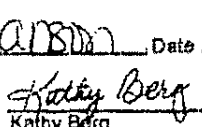
