Alliance Laundry Holdings LLC (Document Number M97000000735) received a Certificate of Administrative Revocation on October 21, 1998 for failure to file a 1998 annual report. Upon contacting the Division of Corporations, I was told that a 60 day notice, dated June 26, 1998 was provided but unfortunately I did not receive the notice. In May 1998, Alliance Laundry Holdings LLC was sold by Raytheon Company (which is the Manager/Member listed on the Florida Document Number) and I can only assume that the notification to file the annual report was forwarded to Raytheon Company and not to our location.
