NEWS CAFE, INC.

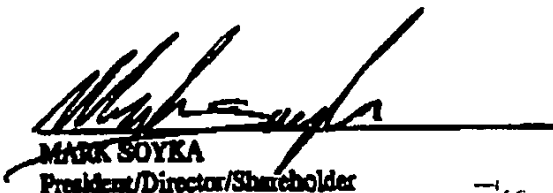
