

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation.


- FIRST: The name of the corporation is ASSOCIATED TREE FARMS, INC.
- SECOND: Text of each of the amendments is as follows:
- a. The name "ASSOCIATED TREE FARMS, INC." is deleted wherever it appears in the Articles of Incorporation and substituted in lieu thereof is the name "B-MC, INC."
 - b. The principal address of the business is changed from "105 Tree Farm Road, Sebring, FL 33872" to "12176 Payne Road, Sebring, FL 33872."
