## ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF WESTFIELD DEVELOPMENT CORP. OF FLORIDA

WESTFIELD DEVELOPMENT CORP. OF FLORIDA, a corporation of an existing under the laws of State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby

I. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on September 12, 1988.

certify as follows:

- II. The amendment to the Articles of Incorporation being effected hereby will completely delete Paragraph FIRST of the Articles of Incorporation as of the date hereof, and substitute in its place the Paragraph FIRST set forth below. As amended below, Paragraph FIRST of the Articles of Incorporation has the sole effect of changing the Corporation's name from "WESTFIELD DEVELOPMENT CORP.
