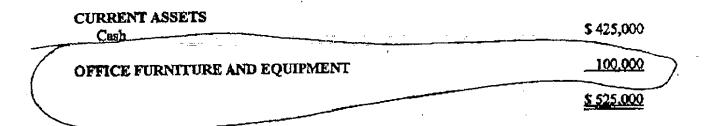

NOTE 1: ORGANIZATION AND FORMATION

Bar None Mortgage, LLC (the "Company") is a California limited liability company formed on May 26, 1998 for the purpose of engaging in residential real estate mortgage lead generation and real estate loan origination through cooperative television commercials and telephone call centers. The Company's members are Newport Mortgage Partners, a California general partnership, ("Newport") and 1-800-Bar None, a Financial Corporation, Inc., a California corporation, ("1-800-Bar None"). Newport owns a 45% membership interest and 1-800-Bar None owns a 55% membership interest in the Company.

The Company was formed with Newport's contribution of \$425,000 in cash and \$100,000 of office furniture and equipment. The office furniture and equipment was acquired by Newport from a related entity known as Bankers Motor Acceptance Corp. and contributed to the Company by Newport at fair market value.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of the balance sheet in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the balance sheet. Actual results could differ from those estimates.

Concentration of Credit Risk

Cash balances are maintained at one bank and are insured by the Federal Deposit Insurance Corporation ("FDIC") up to \$100,000. The Company's cash balances exceeded the Federal depository insurance limit by \$325,000 at July 10, 1998.

Income Taxes

The Company is treated as a partnership for federal and state income tax purposes and does not incur income taxes. Instead, its earnings and losses are included in the personal returns of the members and taxed depending on their personal tax situations. The financial statements do not reflect a liability for income taxes.

Office Furniture and Equipment

Depreciation is computed using the straight-line method, based upon the estimated useful lives of the assets. Expenditures for major renewals and betterments that extend the useful lives of the property are capitalized. Expenditures for maintenance and repairs are charged to expense as incurred.

BAR NONE MORTGAGE, LLC NOTES TO BALANCE SHEET (CONTINUED)

NOTE 3: PROPERTY AND EQUIPMENT

Office furniture and equipment was contributed by Newport on July 1, 1998 at a fair market value of \$100,000 and consists of furniture, computer equipment, fax machines, telephone equipment, and a copier. Accumulated depreciation was not significant as of July 10, 1998.

NOTE 4: AGREEMENTS

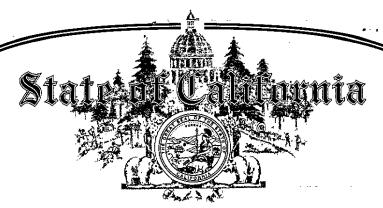
The Company has entered into an agreement with 1-800-Bar None for administrative services including telephone charge pass through, media management, accounting, call processing systems, certain software and database use and maintenance, and the use of the 1-800-Bar None telephone number.

The Company also has entered into an employment agreement with John D. Dewey to serve as Chief Executive Officer (CEO). Mr. Dewey is also a partner in Newport.

At July 10, 1998, no payments had been made under these agreements.

NOTE 5: COMMON CONTROL

The Company shares office space with an entity related to the CEO. Existence of this common control could result in financial position different than if the entities were autonomous.

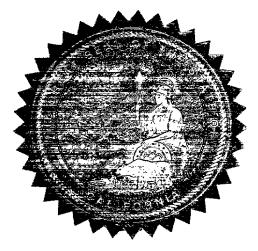
