
Sirs & Madams:



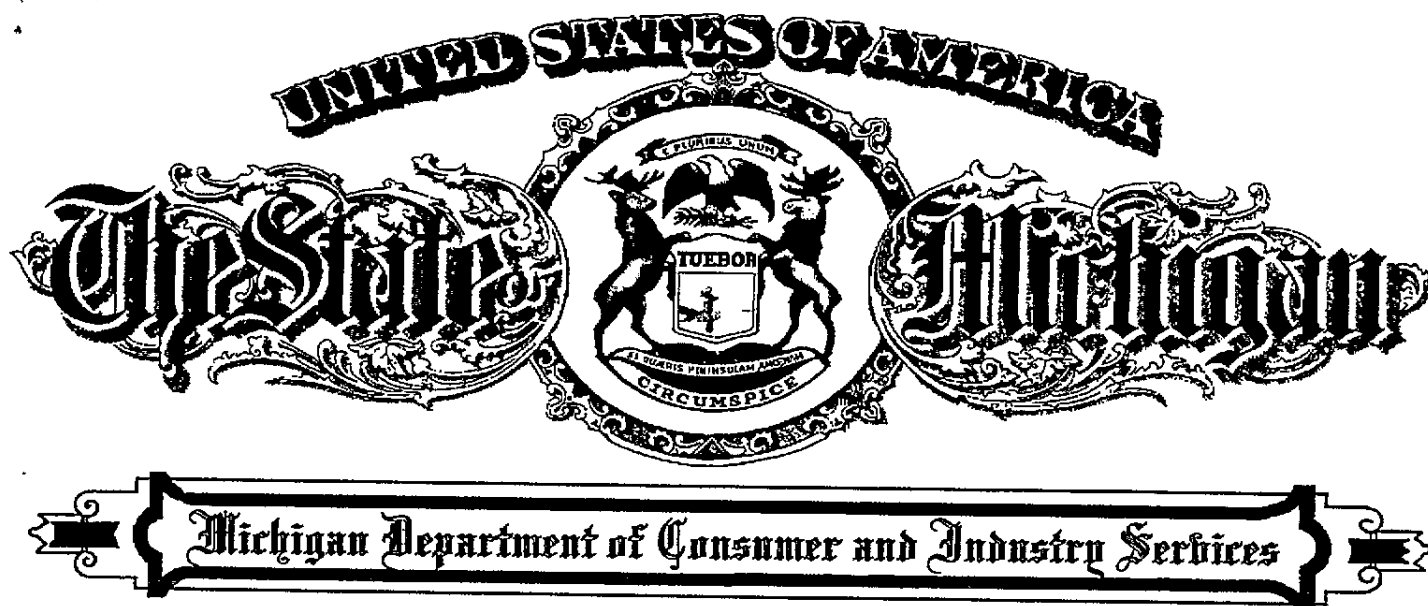
