RESTATED ARTICLES OF ORGANIZATION OF UNIVERSITY TOWERS APARTMENTS, L.L.C.

Pursuant to the provisions of Act 23, Public Acts of 1993, the undersigned limited liability company executes the following Restated Articles:

- 1. The name of the limited liability company is University Towers Apartments, L.L.C.
 - 2. The identification number assigned by the Bureau is B44517.
