Dear Ms. Hodges:

I represent the above-captioned Limited Liability Company, organized in Michigan, but seeking to register to do business in Florida. I am also working with the Michigan attorney, Walter R. Denison, who likewise represents that company.

On <u>February 2, 1996</u> Mr. Denison wrote the Florida Department of State requesting information on a Florida registration and for the necessary forms. A copy of that letter is enclosed herewith.

No reply to that letter was ever received, and Mr. Denison interpreted that lack of response to mean that he need do nothing further until contacted by your Department. However, all required Florida state tax returns were filed and the taxes paid.

Then in <u>December</u>, 1998 he received an undated and unsigned letter from your Department, a copy of which is enclosed herewith. He completed the enclosed forms, paid the requested fees, and sent them in to your Department on March 24, 1999.

Under date of April 6, 1999 you returned his filing to him, along with a letter requesting changes to conform to Florida law, and also penalties in the amount of \$3,581.25. A copy of your letter is also enclosed.

Although Section 608.503 (4), Florida Statutes, provides the mechanics for such penalties, I believe that imposition of them in this case would be manifestly unfair. Mr. Denison and the

Company have complied with every request made of them by your Department. Had they received a response to the letter sent on February 2, 1996, they would have complied immediately. To receive such a response over two and one-half years later, and then to be adjudged delinquent, is not right.

I request that you reconsider the imposition of penalties, so that we can effect the necessary changes to our documentation, and make our filing with you.

I appreciate your courtesy and cooperation, and would further request a response from you at the earliest possible date.


