

- 2.1 <u>Contribution of Assets.</u> Subject to the terms and conditions of this Agreement, in accordance with the LLC Agreement, effective as of the Contribution Date, in exchange for a membership interest in the LLC, the Contributing Company hereby assigns, transfers, delivers, and conveys to the LLC as a contribution, all of the Contributing Company's right, title and interest in and to the following (the "Contributed Assets"):

  - (c) all Finished Goods;
  - (d) to the extent fully transferable, all Contracts, Permits, licenses, and other rights, used exclusively for the operation of the Resins Units or for the Resins Business; and
  - (e) originals or copies of all books of account, records, files and papers, whether in hard copy or computer format, used or held for use exclusively in connection with or relating to the Resins Units or the Resins Business, including without limitation, engineering information, manuals and data, and in respect of information relating to Taxes, only such information that is necessary for the preparation or defense of any tax returns to be filed by the LLC after the Contribution Date.
