Dear Ms. Lunt

We are a very small company. We don't have a full time attorney, we only use an accountant to prepare our annual federal and state tax returns. So we don't have the resources that would tell us if we are compliant with all of the laws of the state and it was total ignorance on our part about the need to register as a foreign corporation. We found out merely by accident when we were consulting an attorney about another matter.

If possible we wish to file an appeal for the \$1000.00 penalty based on the following. When we applied for a Certificate Number with the Department of Revenue, we filed under Greenetree Enterprises LLC and the certificate was granted. Since we started doing business in Florida we have been collecting sales tax as a registered agent with the State of Florida. We believe that the department of revenue has the resources and access to the information that would have shown that Greenetree Enterprises LLC was either not a Florida corporation or that GEL was not registered with the State of Florida. We think that at this point it would have been very simple for them to inform us that we are required to register with your department as a corporation or if we are a corporation from another state as a foreign corporation.

We enclosed \$188.75 for the first year and we ask that you consider our appeal or send it to the proper department for their consideration.

We noticed the following differences in the Corporate Detail Record Screen: There is a difference in the spelling of the name and they are registered as a corporation and we are registered as a Limited Liability Company.
