St. Demiana Coptic Orthodox Church Minutes of Board Meeting- 8-16-2015

The board members met and unanimously approved the amendment of article 14 and 15 to the bylaws of the corporation of St Demiana Coptic Orthodox Church, Inc (formed on December 5th, 1999, and whose document number in Florida is N000000000009) regarding sexuality, gender, and marriage.

The Coptic Orthodox Church defines marriage as the union of one man and one woman and as the foundation of the family unit.

Article 14 and Article 15 to read as follows:

ARTICLE 14

The Corporation defines marriage as one of the seven Mysteries (Sacraments) of the Coptic Orthodox Church, officiated by a consecrated bishop, priest, or both, (or other Orthodox bishop, priest, or both, who is/are in full communion with the Coptic Orthodox Church), in good standing, uniting one man and one woman. The Corporation defines a man as a human being having the reproductive sexual organs of a male from birth and the Corporation defines a woman as a human being having the reproductive sexual of a female from birth.

ARTICLE 15

The Corporation shall take no action(s) contrary to the rules, statutes, regulations and usages of the Coptic Church of Alexandria adopted by the Holy Synod of the Coptic Orthodox church as well as the Synodical Committee for the Coptic Churches in the land of Immigration or the policies of the Bishop of the Coptic Orthodox Diocese of the Southern United States or contrary to the policies of the Bishop of the Coptic Orthodox Diocese of the Southern United States.
