**Articles of Amendment to the Articles of
Incorporation
of
Tampa Street School, Inc.**

The undersigned certify that the following amendments to the Articles of Incorporation of Tampa Street School, Inc. were adopted in accordance with Florida Statutes §617.1002 at a duly called meeting of the directors of the corporation (since there are no members of the corporation other than the directors), held September 27, 1999, by more than a two-thirds (2/3) majority of the directors in office:


Article I is amended as follows:

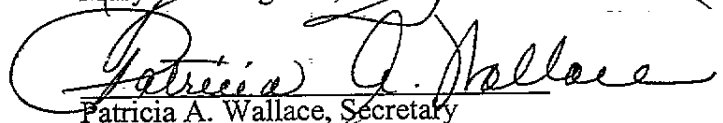
The name of the corporation, which was formerly "Tampa Street School, Inc.," shall be TAMPA STREET SCHOOL ASSOCIATION, INC.

Article XII is added as follows:

The corporation shall have a racially nondiscriminatory policy and shall not discriminate against directors, employees, applicants, students, and others on the basis of race, color, or national or ethnic origin. The corporation shall admit students of any race, color, national and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students and shall be racially nondiscriminatory in the administration of all of its policies and programs.

In Witness Whereof, the undersigned, being the officers of the corporation authorized to execute these Amendments to the Articles of Incorporation by a unanimous vote of the directors of the corporation, do so this 29 day of Nov 1999.
