The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **Clewiston Youth Baseball, Inc.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 108 Myrtle Lane, P.O. Box 1211, Clewiston, FL 33440. All mail to P.O. Box.

ARTICLE III: PURPOSE

The purpose of this corporation is to provide youth baseball.

ARTICLE IV: QUALIFICATION

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT
