A NONPROFIT CORPORATION

WE, THE UNDERSIGNED, by these Articles of Incorporation hereby form a Not-For-Profit Corporation pursuant to the provisions of Chapter 617 of the Florida Statutes.

Article I

The name of this not-for-profit corporation shall be:

Chabad of The Panhandle, Inc.

The principal place of operations of this corporation and the mailing address of the corporation shall be 1500 State Road 7, Margate, FL 33063.

Article II

This corporation is organized for the exclusively for charitable, religious, educational and, literary purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United State Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to Florida Friends of Lubavitch, Inc. which is itself an exempt organization described in sections 501(c)(3) and 170(c)(2) of the Internal revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

Article III

The manner in which the directors are to be elected or appointed is as stated in the by-laws.

Article IV

The general nature of the purposes of this corporation shall be to provide a place of rest, recreation and Orthodox Jewish religious atmosphere, and to conduct religious services in accordance with the tenets and practices of the Orthodox Jewish faith.

To conduct a synagogue in strict accordance with the Orthodox-Halachic interpretation of Torah and Judaism.

To insure that the sacred tradition inherent in Orthodox Judaism will be maintained.

To provide proper facilities for the dissemination of knowledge and learning of Jewish faith, history, literature and Jewish lifestyles and ideals in accordance with Chabad methods.

To conduct religious, educational, and social activities in connection with the observance of Jewish holidays and traditions.

Article V

This corporation is to exist perpetually and shall commence its corporate existence on January 1, 2000.

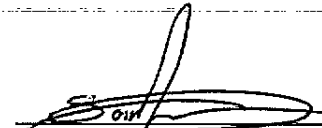
Article IX

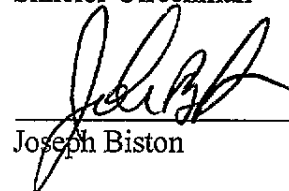
The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.
