ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE 1

The name of the corporation shall be, CHURCH OF CHRIST OF NEW SMYRNA BEACH, INC.

ARTICLE 2

The address of the initial principal office and mailing address shall be 303 Magnolia Street, New Smyrna Beach Florida 32168-7144.

ARTICLE 3

The purposes for which the Corporation is organized are:

- (a) To worship God and to disseminate the teachings of Jesus Christ and the principles of the Christian religion as taught in the New Testament.
- (b) To establish and maintain one or more places of worship.
- (c) To rent, lease, buy, sell, mortgage, maintain or dispose of such property, real or personal, as the purposes of the Corporation may require from time to time.

ARTICLE 4

The directors of the Corporation will be a Board of Trustees, who shall be elected by the method provided in the bylaws.

ARTICLE 5

The Corporation shall not act in any manner which would prevent its designation as a tax exempt organization under the provisions of the Internal Revenue Service or Florida law.

ARTICLE 6
