**ARTICLES OF INCORPORATION  
OF  
CUTTING EDGE FELLOWSHIP CHURCH, INC.**

The undersigned subscribers to the Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, not for profit, under the laws of the State of Florida.

**ARTICLE I**

The name of the corporation is Cutting Edge Fellowship Church, Inc. Its address is 2824 E. Hickory Cir., Mims, Florida 32754.

**ARTICLE II**

The purpose for which this corporation is formed is give corporate existence to the members of a religious organization known as Cutting Edge Fellowship Church, Inc. The object, business, and purpose of this corporation is non-political and shall be devoted to the carrying out of the Great Commission to evangelize the world as was given by Jesus Christ to the Church through the publishing, teaching, preaching of the Word and singing of songs of praise whenever, wherever, and however the opportunity affords itself. Establish Churches, missions, schools, child care facilities, feeding and sheltering under privileged. License and ordain Ministers, Missionaries and Workers in the ministry of "The Gospel Of Jesus Christ".

**ARTICLE III**

The membership of said corporation shall consist of any person who has acknowledged his or her faith in Jesus Christ, without a vote of membership.

**Declaration of Faith**

We believe:

1. In the verbal inspiration of the Bible.
2. In one God eternally existing in three persons; the Father, Son, and Holy Ghost.
3. That Jesus Christ is the only begotten Son of the Father, conceived off the Holy Ghost, and born of the Virgin Mary. That Jesus was crucified, buried, and raised from the dead. That He ascended to heaven and is today at the right hand of the Father as the Intercessor.
4. That all have sinned and come short of the glory of God and that repentance is commanded of God for all and necessary for forgiveness of sins.
5. That justification, regeneration, and the new birth are wrought by faith in the blood of Jesus Christ.
6. In sanctification subsequent to the new birth, through faith in the blood of Christ; through the Word, and by the Holy Ghost.
7. Holiness to be God's standard of living for His people.
8. In the baptism with the Holy Ghost subsequent to a clean heart.
9. In speaking with other tongues as the Spirit gives utterance and that it is the initial evidence of the baptism of the Holy Ghost.
10. In water baptism by immersion, and all who repent should be baptized.
11. Divine healing is provided for all in the atonement.
12. In the Lord's Supper and washing of the saints' feet.
13. In the premillennial second coming of Jesus. First to resurrect the dead and to catch away the living saints to Him in the air. Second, to reign on earth a thousand years.
14. In the bodily resurrection; eternal life for the righteous, and eternal punishment for the wicked.


