# ARTICLES OF INCORPORATION OF CUTTING EDGE FELLOWSHIP CHURCH, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned subscribers to the Atricles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, not for profit,

#### ARTICLE I

The name of the corporation is Cutting Edge Fellowship Church, Inc. It's address is 2824 E. Hickory Cir., Mims, Florida 32754.

#### ARTICLE II

The purpose for which this corporation is formed is give corporate existence to the members of a religious organization known as Cutting Edge Fellowship Church, Inc. The object, business, and purpose of this corporation is non-political and shall be devoted to the carrying out of the Great Commission to evangelize the world as was given by Jesus Christ to the Church through the publishing, teaching, preaching of the Word and singing of songs of praise whenever, wherever, and however the opportunity affords itself. Establish Churches, missions, schools, child care facilities, feeding and sheltering under privileged. License and ordain Ministers, Missionaries and Workers in the ministry of "The Gospel Of Jesus Christ".

#### ARTICLE III

The membership of said corporation shall consist of any person who has acknowledged his or her faith in Jesus Christ, without a vote of membership.

#### Declaration of Faith
