# ARTICLES OF INCORPORATION

- ONE: The name and address of this principal corporation is ***Spiritual Enhancement Training and Resources, Inc., 1110 N. W. 75<sup>th</sup> Street, 33150.*** The corporation is organized pursuant to the **Florida** Nonprofit Corporation Code.
- TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes. To establish structured support services homeless and economically disadvantaged individuals, families and juvenile to a life of self-sufficiency. Programs will consist of, but shall not be limited to: Child Care; Outreach Advocacy Programs for Youth At-High-Risk; Health Care; Temporary Shelter; Permanent Housing; Housing for the homeless; Housing for the Aged; Employability Skills Development and Enhancement, Literacy; Counseling; Teenage Pregnancy; Job Training; Job Placement and Acquisition; Substance Abuse, Awareness, and Prevention; Tutoring; AIDS awareness and prevention; and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, and provide no stock.
- FOUR: The address of the registered office is ***Spiritual Enhancement Training and Resources, Inc., 1110 N. W. 75<sup>th</sup> Street, 33150*** and the name and address of the registered agent of the corporation shall be ***Kevin K. Pryor, 1110 N. W. 75<sup>th</sup> Street, Miami, Florida 33150.***
- FIVE:  
(a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b)

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
