The undersigned incorporators, being competent to contract, subscribe to these Articles of Incorporation to form a NOT-FOR-PROFIT Corporation under the laws of the State of Florida.

ARTICLE I - NAME

ARTICLE II - NOT-FOR-PROFIT ACTIVITIES

ARTICLE IV - TERM OF EXISTENCE
