ARTICLE I - NAME

The name of this corporation is DISCIPLESHIP MINISTRY OF BREVARD COUNTY, INC.

ARTICLE II - PRINCIPAL OFFICE

The initial street address of the principal office of this corporation shall be 1716 Parrsboro St. NW, Palm Bay, Florida, 32907.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of being a non-denomination church and to perform all acts including the conduct of worship services, customarily performed by a church, and for any other lawful purposes.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS


ARTICLE V - INITIAL REGISTERED AGENT AND STREET ADDRESS
