ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is Alafaya Trail Property Owners' Association, Inc. (the "Corporation").

ARTICLE II - INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal place of business and the mailing address of the Corporation shall be c/o Home Depot U.S.A., Inc., Legal Dept., Bldg. C - 20th Floor, 2455 Paces Ferry Rd., N.W., Atlanta, Georgia 30339-4024.

ARTICLE III - PURPOSE

The specific purpose for which the Corporation is formed is to facilitate the delivery of utility services to a multi-parcel development, but in no event for pecuniary profit or any other purpose prohibited under the laws of the State of Florida.

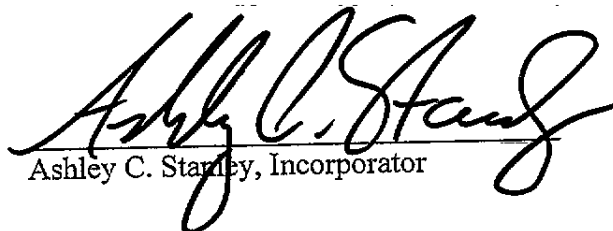
