**ARTICLES OF AMENDMENT
OF
LAKESIDE VILLAGE RESIDENTS ASSOCIATION, INC.**

LAKESIDE VILLAGE RESIDENTS ASSOCIATION, INC., a Florida corporation not for profit, through its undersigned officers, hereby adopts these Articles of Amendment to the corporation's Articles of Incorporation.

2. The Articles of Incorporation are hereby amended as follows:

(a) Article I is deleted in its entirety and the following substituted therefor:

"ARTICLE I - NAME OF CORPORATION


The name of this corporation shall be West Butler Chain Homeowners Association, Inc."
