**ARTICLES OF INCORPORATION
OF
School of Academic Readiness
Christian Academy, Inc.**

The undersigned, acting as incorporators of a Florida corporation not-for-profit under the Florida Not-for-Profit Corporation Act, Chapter 617 of the Florida Statutes, hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of the corporation is School of Academic Readiness
Christian Academy, Inc.

ARTICLE II

PRINCIPLE PLACE OF BUSINESS

The principle place of business and mailing address of the Corporation is
5827 Dunmire Ave. Jacksonville, FL 32219

ARTICLE III

SPECIFIC AND GENERAL PURPOSE

A. The specific and primary purpose for which this corporation is formed is to create, organize and impliment educational activities as a christian school under the laws of the state of Florida educational program specifically:

- (a) Create an enviroment for student learning
- (b) Provide opportunities for all students to maximize and expand their learning experiences as well as identify and address any deficiencies.

- (c) Promote the use of different and innovative learning methods.
- (d) Enhance student motivation by increasing self-esteem.
- (e) Provide standards of behavior and accountability.
- (f) Provide a safe environment where students feel free to express their religious beliefs.
- (e) Require the measurement of learning outcomes and skill mastery of the basic five (reading, writing, mathematics, science and the arts).
- (f) Create an environment where teachers can use new methods to address all the needs of the student in order to promote learning.

B. The general purpose for which this corporation is formed is to operate exclusively for educational purposes that will provide the student and parent with a Christian Education as well as qualifying it as an exempt educational organization under Section 501 (c) (3) of the Internal Revenue Code or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions of organizations which qualify as tax exempt organizations under the Code.

C. Notwithstanding any other provisions of these articles of incorporation, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or corresponding provision of any subsequent federal tax laws or (b) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code or corresponding provisions of any subsequent federal tax laws.

D. This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

- E. This Corporation shall provide basic Christian Doctrines in its program and not promote any denomination or organization. No student will be denied admission due to race, creed or national origin. Tuitions and all applicable fees will be provided for review prior to admissions to the academy. Parents will be asked to provide a signed letter of commitment to abide by all the rules and regulation of the academy as stated in the Student and Parent Handbook.
- F. This corporation shall be a Christian, Bible based educational institution. The rules and character building education will be based on the Word of God.

ARTICLE IV

DURATION

This corporation shall exist perpetually.

ARTICLE V

MEMBERSHIP




The members of this corporation shall consist of the organizing group of initial incorporators. This corporation will be subordinate to and subject to the organizing group of initial incorporators' vision and mission for the School of Academic Readiness Christian Academy, Inc. The academy will also foster and develop an Advisory Council which will consist of a well balanced group of people with a range of professional expertise in organizational, financial, legal and other skills to enhance the operational quality of the school.

ARTICLE VI

INCOPORATORS

The Initial Board of Directors/Incorporators shall be elected or appointed by the members; and in accordance with the bylaws of this not-for-profit corporation to maintain continuity between the founding organizers and the established board of directors.
