ARTICLES OF INCORPORATION

OF

ARTICLE # 1 NAME: The name of the corporation is:

ISLAMIC SOCIETY OF WEST VOLUSIA, INC.

ARTICLE # 2 A. This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law exclusively for religious purposes.

B. The specific purpose of this corporation is to preach the religion and teachings of Islam through various means, resources and methods.

ARTICLE # 3 The name and address in the state of Florida of this corporation's initial registered agent for service of process and the initial principle address is:

ARTICLE # 4 A. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code.


B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the corporation shall not participate or intervene in any political campaign (including the publication or distribution of statements) on behalf of any candidate for public office.

C. The method of election of directors is as stated in the bylaws.

ARTICLE # 5

The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a non profit fund, foundation or corporation which is organized and operated exclusively for religious purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
