

The undersigned subscriber, a natural person competent to contract, hereby presents these Articles for the formation of a corporation not for profit, under the laws of the State of Florida.

## ARTICLE I

## CORPORATE NAME

The name of this corporation is ISLAMIC INFORMATION NETWORK, INC.

#### ARTICLE II

## CORPORATE EXISTENCE

The corporate existence of this corporation shall commence on the signing of these Articles of Incorporation and shall exist perpetually thereafter, unless sooner dissolved according to law.

#### ARTICLE III
