RESTATED ARTICLES OF INCORPORATION OF

OCEAN PALMETTO CONDOMINIUM ASSOCIATION, INC. f/k/a OCEAN PALMETTO BUILDING ASSOCIATION, INC. A FLORIDA CORPORATION NOT FOR PROFIT

ARTICLE I. NAME AND ADDRESS

The name of this Corporation is OCEAN PALMETTO CONDOMINIUM ASSOCIATION, INC. For convenience, the Corporation shall be referred to in this instrument as the "Association," these Articles of Incorporation as the "Articles," and the Bylaws of the Association as the "Bylaws."

The street address of the initial principal office of the Association is 980 North Federal Highway, Suite 434, Boca Raton, Florida 33432.

ARTICLE II. TERM OF EXISTENCE

The Association shall have perpetual existence.

ARTICLE III. PURPOSE

This Association is organized for the purpose of providing an entity under the Florida Condominium Act ("the Act") for the operation of a Commercial Condominium located in Palm Beach County, Florida, and known as Ocean Palmetto, a Commercial Condominium ("the Condominium"), to be created under the Declaration of Condominium ("the Declaration").

ARTICLE IV. MEMBERS

The members of the Association shall consist of the Unit Owners, and their qualifications and the manner of their admission shall be as regulated by the Bylaws.

ARTICLE V. INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of this Association is 980 North Federal Highway, Suite 434, Boca Raton, Florida 33432, and the name of the initial registered agent

of this Association at that address is Steven D. Rubin.

ARTICLE VI. BOARD OF DIRECTORS

ARTICLE VI. POWERS

The Association shall have the powers enumerated in Florida Statutes \S 718.111, as it may be amended from time to time.

ARTICLE VII. VOTING

Subject to the restrictions and limitations hereinafter set forth, each Member shall be entitled to one (1) vote for each Unit in which such Member holds the interest required for membership. The manner of voting is more fully described in and regulated by the By-Laws

of the Association.

ARTICLE VIII. OFFICERS

The Association shall have a President, a Vice-President, a Secretary and a Treasurer, and such other officers and assistant officers and agents as the Board of Directors may from time to time deem desirable or consistent with the By-Laws of the Association.

ARTICLE IX. BY-LAWS

In the event of a conflict between the provisions of these Articles and the provisions of the By-Laws, the provisions of these Articles shall control.

ARTICLE X. AMENDMENT TO ARTICLES OF INCORPORATION

These Articles may be altered, amended or repealed in the manner set forth in Chapters 718 and 617 of the Florida Statutes, as may be amended from time to time.

A copy of each amendment so adopted shall be filed within ten (10) days of adoption with the Secretary of State, pursuant to the provisions of applicable Florida Statutes and the same shall be recorded among the Public Records of Palm Beach County, Florida.

ARTICLE XII. INDEMNIFICATION OF OFFICERS AND DIRECTORS

The Association shall indemnify Directors and Officers of the Association in the manner set forth in the By-Laws of the Association.

ARTICLE XIII. TRANSACTIONS IN WHICH DIRECTORS OR OFFICERS ARE INTERESTED

No contract or transaction between the Association and one or more of its Directors or Officers, or between the Association and any other corporation, partnership, association, or other organization in which one or more of its Directors or Officers are Directors or Officers, or have a financial interest, shall be invalid, void or voidable solely for this reason, or solely because the Director or Officer is present at or participates in the meeting of the Board or committee thereof which authorized the contract or transaction. No Director or Officer of the Association shall incur liability by reason of the fact that such person is or may be interested in any such contract or transaction.

Interested Directors shall be counted in determining the presence of a quorum at a meeting of the Board of Directors or of a committee which authorized the contract or

transaction, and an interested Director shall be entitled to vote on any contract or transaction in which he or she has an interest as defined herein.
