## **ARTICLES OF INCORPORATION**

*Of*

**Community Outreach Development Center Inc.**

**A Nonprofit Corporation**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

### **ARTICLE I**

The name of this corporation shall be:

**Community Outreach Development Center Inc.**

### **ARTICLE II**

The principle place of business and mailing address of this corporation shall be:

Sunrise, Florida 33313**

### **ARTICLE III**

The specific purpose for which the  
Community Outreach Development Center Inc. is organized is:

- (1) to reach out to socially and economically disadvantaged women, displaced workers and welfare recipients and offer free career assessment, counseling and training to fill jobs internally or within the community;
- (2) to train women in very low and low income neighborhoods to become ANA coordinators that meet one-on-one with community leaders, parents, churches, schools, and businesses to assess and obtain suggestions for rectifying the immediate needs of their community.
- (3) to work as an intermediary/liaison for obtaining private and/or government grants for individual, small business or community needs.
- (4) to offer self-improvement workshops and weekly support groups for women.
- (5) to offer a database that provides a critical link to other non-profit organizations, community services and information
- (6) to provide research on the benefits, effects and costs of different welfare reform interventions. To study and analyze outcome measures for evaluating the success of the States in moving individuals out of the welfare system into employment; and to evaluate how Welfare-to-Work grants have been used.

The Community Outreach Development Center Inc. is currently conducting a six-month pilot program in the greater Ft. Lauderdale area. This pilot program is scheduled to end June 2000. Our gradual three-year expansion plan is designed to encompass multiple empowerment zones on a national level.

Our goal is to carry out a range of community development activities directed towards neighborhood revitalization, economic development, and improved community services as well as instill a positive self-esteem within women which will lead them to accomplishing their academic and career goals (self-sufficiency) while living as a positive example in their communities.

### **ARTICLE IV**

The manner in which the Directors are elected or appointed will be  
at a meeting of the incorporator held annually on the 3<sup>rd</sup> Friday of January.




