ARTICLES OF INCORPORATION OF FOREST LAKE ESTATES NON SHAREHOLDERS HOMEOWNERS ASSOCIATION, INC.

I, the undersigned, acting as incorporator of a non-profit corporation under Chapter 617 Florida Statutes, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I Name of Organization

The name of the corporation (hereinafter called the "Association") is FOREST LAKE ESTATES NON SHAREHOLDERS HOMEOWNERS ASSOCIATION, INC.

ARTICLE II Office

The principal office of the association shall be at; 6359 Spring Lake Drive, Zephyr lills, 33540.

ARTICLE III Purposes

The purposes for which this association is formed are:

- a. To own, operate and maintain a club exclusively for the pleasure, entertainment, recreation and protection of non equity residents of FOREST LAKE ESTATES MOBILE. HOME PARK, ZEPHYRHILLS, FLORIDA, to improve relations between the association, members and park management and to exercise any rights that it may have pursuant to Chapter 723 of the Florida Statutes.
- b. To be organized and operated exclusively for the above stated purposes, and for other nonprofit purposes, and no part of any net earnings shall insure to the benefit of any member.
- c. Affix, levy, and collect, and enforce payment by any lawful means of all charges and assessments; and pay all expenses in connection therewith, and all office and other expenses incidental to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied on or imposed against the property of the Association.
- d. Acquire (by gift, purchase, or otherwise), own, hold, and improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate to public use, or otherwise dispose

of real and personal property in connection with the affairs of the Association.

- e. Establish rules and regulations governing members' responsibility.
- f. Sue and be sued.
- g. Contract for services, such as to provide for operation and maintenance if the Association contemplates employing a maintenance company.

ARTICLE IV <u>Powers</u>

In furtherance of the objectives described above, but not in limitation thereof, the association shall have the power, insofar as such power is conferred, or is not limited, by law, to make and perform contracts for any lawful purpose, to engage in various funding and fund-raising activities, and to acquire, own, hold, operate, and maintain such property as is necessary to effectuate its purposes.

ARTICLE V <u>Membership</u>

Membership shall be limited to non-equity unit owners in Forest Lake Estates Mobile Home Park who monthly pay lot rent to the Forest Lake Estates Co-Op.

ARTICLE VI <u>Voting</u>

Each member shall be entitled to one (1) vote.

ARTICLE VII <u>Directors</u>

The powers of the association shall be exercised and its property controlled by the Board of Directors, comprised of not more than nine (9) members and no less than three (3). The qualifications, the time and manner of electing, the terms and duties of office, and the manner of filling vacancies shall be set forth in the bylaws.

Bylaws will be hereafter adopted. Such bylaws may be amended or repealed, in whole or part, in the manner provided therein, and the amendments to the bylaws shall be binding on all members, including those who may have voted against them.

ARTICLE XI <u>Dissolution</u>

This association shall be dissolved and its affairs concluded by a majority vote of the association's membership.

In the event of dissolution, property of the association shall be distributed in any manner lawfully entitled by law and approved by majority vote of the association's membership.
