Pursuant to the powers granted to the General Overseer, these ensuing Articles of Amendment shall be incontestably incorporated into the governing documents of All Nations New Testament Church of God Fellowship INC.

- In the absence of the General Overseer/President Bishop Evan Augustus Grant, of the All Nations New Testament
 Church of God Fellowship INC., including but not limited to being incapacitated, all powers of the General
 Overseer/President shall be granted to the Vice President, hereinafter referred to as the VP. Krista-Gaie E. Grant.
- 2. In accordance with the above, the VP, Krista-Gaie E, Grant, shall have sole discretion in the decision making and managing the affairs of the Head Quarter Church, located at 4351 West Oakland Park Boulevard, Lauderdale Lakes. FL 33313 and other locations domestically, as well as those in foreign countries (May Pen, Clarendon and Falmouth, Trelawny in Jamaica). This includes the Church Manse, located in Margate. Florida and all recognized entities using a fictitious name (DBA) International Faith For Christian Fellowship. Inc. and Faith Christian Fellowship Training Institute.

For all decisions as may be necessary from time to time, including but not limited to financial, titular and/or Officer appointments, ordinances, management and leadership the All Nations New Testament Church of God Fellowship INC shall be vested solely with the General Overseer/President Bishop Evan Augustus Grant and/or the VP. Krista-Gaie E. Grant. Under no circumstance shall any other titular individual or Officer have any authority or power to initiate meetings, unless so directed by the General Overseer/President Bishop Evan Augustus Grant, or the VP, Krista-Gaie E. Grant, make decisions, dispense of funds of the assembly, or the disposition of any assets or holdings of the All Nations New Testament Church of God Fellowship INC.

- 3. All donations, gifts, bequeaths, tithes, offerings and devises in cash or kind, to All Nations New Testament Church of God Fellowship INC are final. In no event shall any demand or contest be made against All Nations New Testament Church of God Fellowship INC., the General Overseer/President Bishop Evan Augustus Grant, the VP, Krista-Gaie E. Grant and any subsequent demand or contest thereafter shall be void and invalid ab initio.
- 4. The Church year starts on September 1st annually.

- 5. Ordained and/or position appointments by the General Overseer/President Bishop Evan Augustus Grant, or, the VP Krista-Gaie E. Grant of Pastors, Associate Pastors, Officers, or, for any other titular position(s) as may be appointed or ordained from time to time, shall not be guaranteed to be permanent from year to year and may be revoked for causes including, but not limited to that of disavowing of the tenets of The Holy Bible, all acts of moral turpitude.
- The Head Quarter Church shall be responsible to provide for health insurance for the General Overseer/President Bishop Evan Augustus Grant.
- 7. Upon retirement of the General Overseer/President Bishop Evan Augustus Grant, must receive Five Thousand Dollars (US\$5,000,00) each month from the Head Quarter Church. Each year thereafter, must be increased by twenty percent (20%).
