Amended Article III - Purpose: Christ Community Church of Orlando, Florida, Inc. is a non-profit corporation organized exclusively for religious, charitable, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Amended Article - Dissolution Statement (added and filed to Articles of Incorporation on October 16, 2009) shall now become Amended Article VIII.

Added Article VII: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of Christ Community Church, Orlando, Florida, Inc. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or
