**Articles of Incorporation
Of
Molding Outcomes, Incorporated**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**Article I
Name**

The name of the corporation is Molding Outcomes, INC

**Article II
Principal Office**

The address of the initial principal place of business of the Corporation is Molding Outcomes, 4908 East Idlewild Avenue Suite B, Tampa, Florida 33610.

**Article III
Purpose**

The corporation was established in January 2000 for the purpose of alleviating overburdened social service agencies by placing at risk teenage girls in a safe, nurturing and enriching residence to girls who otherwise would not have a place to live. Furthermore, to provide them with the tools to become positive, successful and productive citizens.

**Article IV
Manner of Election of Directors**

The affairs of the corporation are to be conducted by a Board of Directors of not less than five (5) or more than (9) members, the numbers to be set by the directors as provided in the by laws. The board members shall have the power to increase or decrease the number of directors on the Board of Directors last approved pursuant to and in accordance with the limitations

provided by Florida law; provided however that at no time shall the number of directors be less than five (5) or more than (9) without amendment of this Article. Any additional director or directors elected to fill a vacancy shall be elected by the vote of a majority of the directors then in office. Any director so chosen shall hold office for a term that shall expire at the time of the next annual meeting at which directors are elected. In no case will a decrease in the number of directors shorten the term of any incumbent director.
