**ARTICLES OF INCORPORATION**  
**OF**  
**GOOD NEWS IN SOUTH FLORIDA, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**FIRST.** The name of this corporation is Good News in South Florida, Inc .

**SECOND.** The address of the initial principal office and the mailing address of the corporation are 2401 W. Cypress Creek Road, Ft. Lauderdale, FL 33309.

**THIRD.** The address of the registered office in the State of Florida is 2401 Cypress Creek Road, Ft. Lauderdale, FL 33309. The Registered Agent in charge there of is Mark Davis.

**FOURTH.** The general purpose for which this corporation is organized are exclusively religious, charitable, literary, or educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code. Without limiting the generality of the foregoing, Good News of South Florida, Inc. is organized to act for the sole purpose to prologuize the Gospel of Jesus Christ in an effective and efficient manner.

This corporation shall have the power to purchase, lease or otherwise acquire property, support missionaries and missions, raise funds, and do those things necessary to prologuize the Gospel in an adequate manner.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Taxes under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue Law.

**FIFTH.** The qualification for members and the manner of their admission are set forth in the Bylaws of the Corporation. The manner in which directors shall be appointed or elected will be determined in the Bylaws.

**SIXTH.** The name and address of the incorporator is as follows:  
Incorporating Services, Ltd. - 15 East North Street, Dover, DE 19901

**SEVENTH.** The corporation is to have perpetual existence.


**EIGHTH.** It is the intention that the objects, purposes and powers specified in the third paragraph hereof shall, except where otherwise specified in said paragraph, be nowise limited or restricted by reference to or inference from the terms of any other clause or paragraph in this certificate of incorporation, but that the objects, purposes and powers specified in the third

paragraph and in each of the clauses or paragraphs of this charter shall be regarded as independent objects, purposes and powers.

**NINTH.** No director of the Corporation shall be liable to the Corporation or its members for monetary damages for breach of fiduciary duty as a director, except for liability (i) for any breach of the director's duty of loyalty to the Corporation or its members, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, or (iii) for any transaction from which the director derived an improper personal benefit.
