ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

Article I Name

The name of the corporation shall be: **S.O.Y. (Save-Our-Youth) Incorporated**

Article II Principal Office

The principal place of business and mailing address of this corporation shall be:

Article III Purpose(s)

The specific purpose(s) for which the corporation is organized is (are): Combating Juvenile Delinquency by providing a place where youth ages 7-17 can come and enjoy fellowshiping with their friends, family and neighbors. We will provide entertainment equipment such as pool, air hockey, foosball, Ping-Pong tables, etc.; video game systems such as Nintendo, Playstation, etc.; G or PG movies on a 25-inch color television; Boom box for music and other similar activities. We also plan on educating and increasing the knowledge of our youth in areas such as law, school policies, fire safety, gun safety, hazards of drugs and cigarettes etc. This will be accomplished by having professionals from the local community come on a volunteer basis and provide lessons, teachings, seminars, discussions etc.

Article IV Manner of Election of Directors

The manners in which the directors are elected or appointed are:

The initial registered agent/incorporator will act as chairman of the board of directors and will be responsible for appointing a vice-chairman and secretary. The chairman and vice-chairman will be responsible for appointing persons to fill any vacancies in the position of secretary. In the event the position of vice-chairman becomes vacant, the chairman will be responsible for appointing someone to fill that position. In the event the position of chairman comes available, the vice-chairman shall assume such position and appoint a vice-chairman.

Article VI Distribution of Funds

No part of the net earnings of S.O.Y., Incorporated shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third thereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or in

opposition to any candidate for public office. "Notwithstanding any other provisions of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."

Article VII Distribution of Assets Upon Dissolution of Corporation

Upon the dissolution of S.O.Y., Incorporated, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
