ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF FLORIDA SPACE RESEARCH INSTITUTE, INC.

The undersigned, Adrian Laffitte, Secretary/Treasurer of FLORIDA SPACE RESEARCH INSTITUTE, INC., a Florida not for profit corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Amended and Restated Articles of Incorporation of the Corporation:

ARTICLE FIRST: ARTICLE XI of the existing Amended and Restated Articles of Incorporation is hereby amended by deleting the existing ARTICLE XI in its entirety and restating it as follows:

ARTICLE XI – DISSOLUTION

Upon the liquidation or dissolution of the Corporation, its assets, if any remaining after payment (or provision for payment) of all liabilities of the Corporation, shall be distributed to the federal government, or to a state or local government, for a public purpose, or to any one or more organizations qualified as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as hereafter amended, and the applicable rules and regulations thereunder. No part of the assets or the net earnings, current or accumulated, of the Corporation shall inure to the benefit of a private individual.

ARTICLE SECOND: These Articles of Amendment to the Amended and Restated Articles of Incorporation shall become effective upon filing with the Florida Department of State.

ARTICLE THIRD: The foregoing amendment to the Amended and Restated Articles of Incorporation reflected in Article First above was duly adopted and approved at a regular meeting of the Board of Directors and members of the Corporation on the <u>2nd</u> day of June, 2006, and the necessary number of votes as required by statute were tallied in favor of the amendment.

These Articles of Amendment to the Amended and Restated Articles of Incorporation were duly adopted in accordance with Sections 617.1001 and 617.1002 of the Florida Not for Profit Corporation Act.
