

ARTICLE I

The name of the corporation is CONCRETE RESTORATION ASSOCIATION, INC.

ARTICLE II

The street address of the initial principal office is 206 North Old Dixie Highway, Jupiter, FL 33458.

The mailing address of the corporation is the same.

ARTICLE III

The purpose for which the corporation is organized is to promote professionalism in concrete restoration: (1) by educating and informing Co-operatives, Condominium Associations, governmental entities, and other owners of concrete structures, particularly medium and high-rise concrete structures as to the scientific explanation behind the current widespread deterioration in concrete balconies, parking garages, and other building components made of concrete reinforced with metals; (2) by providing education and advise on the effectiveness of the various concrete reconstruction techniques now being employed and specific recommendations for and against those techniques; and (3) by providing a reference source for owners to contractors and sub-contractors who meet the Association's qualifications to perform concrete reconstruction.

ARTICLE IV
