### EARLY ENTERPRISE MANAGEMENT INTERNATIONAL CORP., INC.

1. Article III, Purpose, section (a) Early Enterprise Management International Corp., Inc. shall be amended to read as follows:

#### Article III

(a) To operate exclusively for charitable and educational purposes, related to the promotion and support of educational sports entertainment for colleges and high schools. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code), or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code).
