ARTICLE OF INCORPORATION

OF

LEARN AMERICA INSTITUTE, INC. A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned, acting as the incorporator of a not-for-profit corporation under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such corporation:

ARTICLE 1: NAME

The name of the Corporation shall be: <u>LEARN AMERICA INSTITUTE</u>, <u>INC</u>; hereinafter referred to as the "Corporation".

ARTICLE 11: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and mailing address for the "Corporation" is 3972 N.W. 36th Street, Suite B, Miami, Fl 33142, in the City of Miami, County of Miami-Dade.

ARTICLE 111: DURATION

The period of duration of the "Corporation" shall be perpetual unless dissolved according to law.

ARTICLE 1V: PURPOSES

The "Corporation" is organized and operated exclusively for charitable, educational, cultural, health, and scientific purposes within the meaning of Section 501 (c) (3) of the loternal Revenue Code of 1986, as amended. Notwithstanding any other provision of these Articles, the "Corporation" shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code of 1986, (or the corresponding provision of any future United States Internal Revenue Law), or (ii) by contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE V: RESTRICTIONS ON ACTIVITIES

No substantial part of the activities of this "Corporation" shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this "Corporation" participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE V1: MEMBERSHIP

The "Corporation" shall be a membership organization composed of those people hereinafter listed as the initial Board of Directors and all other persons or organization elected/selected for membership as provided in the bylaws.

ARTICLE V11: REGISTERED OFFICE AND AGENT

The *Corporation's" registered office shall be located at 3972 N.W. 36th Street Miami, Fl 33142, in the City of Miami, County of Miami-Dade, and Lardis Llamo is the Registered Agent of the Corporation at that address.

ARTICLE V111 BOARD OF DIRECTORS

The initial Board of Directors shall consist of (3) persons. The number of Directors may be increased or decreased from time to time by an amendment to the by-laws; however, there shall never be less than three Directors. All Directors shall be selected as provided for in the bylaws.

ARTICLE 1X: OFFICERS

The Officers of the "Corporation" shall be a President, Vice President, Secretary, Treasurer and such other Officers as may be provided by the bylaws.

ARTICLE X: AMENDMENTS

These Articles of Incorporation may be amended at any regular or special meeting of the Board of Directors by a majority vote of those present; provided that notice of the intention to submit amendments shall have been given as provided by the bylaws.

ARTICLE X1: DISTRIBUTION OF ASSETS UPON DISSOLUTION

The property of this "Corporation" is irrevocable dedicated to charitable, educational, cultural, health, and scientific purposes, and no part of the net income or assets of this corporation shall ever inure to the benefit of any Director, Office or member thereof or to the benefit of any private person. Upon dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational, cultural, health and scientific purposes, and which has established its tax status under Section 501 (c) (3) of the Internal Revenue Code.
