CHARTER OR

ARTICLES OF INCORPORATION

OF

IGLESIA PENTECOSTAL CASA DE ORACION NACIONAL, INC

We, the undersigned persons of the State of Florida, all of whom are of legal are, each being competent to contract, hereby form ourselves and our successors into a corporation not for profit under the Laws of the State of Florida, and hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: IGLESIA PENTECOSTAL CASA DE ORACION NACIONAL, INC., with its principal place of business located at 9817 N. Nebraska Avenue, Tampa, Florida 33612, Hillsborough County, Florida. The name of this corporation's initial registered agent and her address is Carmen Rivera Torres and his address is 11725 N. 17th Street, Apt. 103, Tampa, Florida 33612.

<u> ARTICLE II - PURPOSE</u>

To establish and maintain a place for the worship of Almighty God, to provide for Christian fellowship for those of like precious faith where the Holy Ghost may be honored according to our distinctive testimony; To assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ, by all available means, both at home and abroad.

ARTICLE III - PROPERTY

The Corporation shall have the power to buy, acquire, and hold title in fee simple, in trust, or otherwise, to both real and personal property, to borrow money, execute notes, bonds, and other evidences of indebtedness and to secure the same by mortgages and deeds of trust, annuity bond, and other instruments of indebtedness and to pay interest thereon, to improve, adapt, and use property held by for IGLESIA PENTECOSTAL CASA DE ORACION NACIONAL, INC., or income therefrom in the religious, educational, benevolent, or social activities of IGLESIA PENTECOSTAL CASA DE ORACION NACIONAL, INC., or its successor without financial profit to its members except as may be necessary in the payment of salaries, or other compensation for services rendered, and the corporation shall have the power to erect and maintain buildings to be utilized by the said church, for the worship of God, for the training in the Christian faith, and to build and maintain residences for the use and occupancy of the ministers of IGLESIA PENTECOSTAL CASA DE ORACION NACIONAL, INC., in conformity with the by-laws of said corporation and all the power a right granted to Corporation Not For Profit under the laws of the State of Florida.

ARTICLE IV - MEMBERSHIP

The members of the corporation shall be all members in good standing at any given time of IGLESIA PENTECOSTAL CASA DE ORACION NACIONAL, INC. Provided, however, neither the incorporators nor the members of the corporation shall have any vested right, interest, or privilege which may be inheritable, or shall continue after his membership ceases in the forenamed corporation. The corporation shall not have the power to buy, mortgage, sell encumber or deed or dispose of any property which it may acquire, without the consent or the direction of a two-thirds (2/3) majority vote of the members, or its successors.

ARTICLE V - TERM

This corporation shall exist perpetually or until dissolved by due process of the law, should this corporation cease to exist as a legal entity and its charter be terminated.

ARTICLE VII-OFFICERS

The number of Directors may be changed from time to time by amendment to this corporation's bylaws, but at all times must be at least four (4). They will be elected every year by the general membership.
