ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

The Florida African-American Fellowship of the Southern Baptist Convention, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is rganized is(are):

1. To work in harmony with the Florida Baptist Convention in fulfilling the great commission through support of the cooperative program.
2. To promote fellowship and cooperation among the African-American churches of the Florida Baptist Convention.
3. To promote and encourage cooperation in the program's work and meetings of the Florida Baptist Convention and local associations.
4. To encourage and maintain a spirit of fellowship and cooperation among the African-American churches.
5. To encourae the African-American churches to participate in and to support the programs and ministries of the Florida Baptist Convention (i.e. church planting, church development and evangelism).

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

Executive Board

The Executive Board shall consist of seven (7) elected officers and four (4) regional at large members.

Terms of Office

- A. A term of office shall be two years.
- B. No officer may serve more than one consecutive term.
- C. The out-going president may serve as a non-voting member of the executive board for one year.

Elections

There shall be an election every two years in the general session.

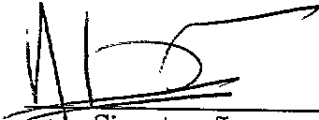
