4. To assist or advise members on flight instruction towards obtaining an ultralight pilot's certification.

5. To assist or advise members with an ultralight pilot's certification on how to obtain a Basic Flight Instructor's rating.

6. Our ultimate goal is to attain the highest possible standards of ultralight flying and comradeship.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS:

4. To be elected, a nominee must have a clear majority of the votes. (Only members of the organization are allowed to vote.) In the event a ballot results in a tie or fails to provide a clear majority, the two nominees holding the most votes for any given position will compete in a run-off election and the nominee with the greater number of votes in that election will be awarded the position.

5. Voting shall be done by secret, written ballot.

6. Term of office shall be one calendar year with installation occurring at the January meeting following the December meeting in which the elections were held.
