ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following articles of incorporation.

ARTICLE I NAME

The name of the corporation shall be **Liberian Education Achievement Foundation Inc.**

ARTICLE II PRINCIPAL OFFICE

ARTICLE V INITIAL REGISTERED AGENT AND STREET ADDRESS






