I am writing to ask for reinstatement of the Liberian Education Achievement Foundation (Document # N00000000758) to an "active" status.

My office did not receive a uniform Business Report this year, with the exception of the Dissolution and Revocation Letter.

I am a member of the US Military (US ARMY) and was deployed in Kosovo, on a peace Keeping Mission for the first six and a half months of this year. Upon my returned to the states and office, I did not receive any other correspondence from your office alerting me of my failure to file the Uniform Business Report (with the exception of the Dissolution and Revocation Letter).


We have also relocated to a new principle office in April this year (2002), which may also be a reason why we did not receive you correspondences.

I ask that you please reconsider and reinstate the Liberian Educational Achievement Foundation to an "active" status without penalty.
