*Having been voted upon and accepted by a majority two-third (2/3) vote of the members of the board of Directors of the Liberian Education Achievement Foundation Inc. the following amendment is hereby adopted.*

**Article I Name**

The name of the corporation shall be **Liberian Educational Achievement Foundation Inc.**

**Article III Purpose (s)**

This organization is organized and operated exclusively for charitable and educational purposes within the meaning of section 501(C)(3) of the Internal Revenue Code.

**Article VII Dissolution(s)**


Upon the dissolution of the organization the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the organization dispose of all the assets of the organization exclusively for the purposes of the organization in such a manner, or to such organization or organizations organized and operated exclusively for charitable or educational purposes as shall at the time qualify as an exempt organization or organizations under section 501(C)(3) of the Internal Revenue Code.
