# **Not For Profit Articles of Incorporation**

### Article I: NAME

The name for this not for profit corporation will be as follows: Independent Contractors Association Corporation.

# Article II: Principle Office

The principle place of business for the above named corporation will be at 1099 Laurel Oaks Court, Oviedo, Florida 32765. The mailing address will be the same.

### Article III: Purpose

The Independent Contractors Association is being organized for the purposes of conducting business in the State of Florida in the following regards: To create an association of individuals that earn monies on a 1099 tax basis or own a small business that is fewer than 10 in employees; To promote a membership which will be able to meet, network, and organize in a lawful manner to promote the group's civic and business ideas; To provide access to information that will help individual members in matters not limited to furthering education, increased licensing, professional regulations, and the like; To promote involvement in the local community and political affairs; To promote professionalism and decency for any industry that members may be a part of.
