The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation Not For Profit, pursuant to the provisions of the Florida Business Corporation Act.

ARTICLE I - NAME

The corporate name for the corporation (hereinafter called the "corporation") is BRMI, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE(S)
